The doctorate program is a four-year, thesis-based program. The program of study is determined by the student's supervisory committee based on past academic and professional experience. Normally, students would complete six courses, four graduate seminars, a comprehensive exam, and a dissertation.

## Admission Requirements:

- Master's degree in a related discipline from a university of recognized standing.
- Master's thesis or have related research experience.
- Meet the MUN English proficiency requirements (complete an undergraduate degree from an English speaking recognized University or have satisfactory English testing scores).
- an undergraduate statistics course.
- Have satisfactory appraisals from two referees.
- Find a faculty member in the division who is will to be her/his supervisor.

NOTE: Students seeking full-time status will also be required to secure funding. Should funding not be available, the student may choose to study part-time. Admission to the doctoral program is competitive and not all qualifying students are admitted to the program. The Division of Community Health reserves the right to refuse admission to any applicant.
